



Release, Assumption of Risk, Waiver And Release of Liability

THE ARSENAL FOOTBALL CLUB, INC. RELEASE, ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY

WHEREAS, The Arsenal Football Club, Inc. (the “Club”) offers to individuals ages six (6) to nineteen (19) soccer instruction during practices, clinics, games and tournaments and other events that the Club may hold from time to time (the “Club’s Activities”); and

WHEREAS, the undersigned desires to participate in the Club’s Activities.

NOW, THEREFORE, in consideration of my being permitted to attend the Club’s Activities, I, the undersigned, intending to be legally bound, hereby agree as follows:

I acknowledge and agree that there are certain inherent risks, dangers and hazards, known and unknown, associated with participating in the Club’s Activities, and I fully realize the dangers of participating in the Club’s Activities. I fully understand that my participation in the Club’s Activities may result in injury to me, including but not limited to bodily injury, disease, illness, strains, fractures or other ailments that could cause serious disability, partial and/or total paralysis or death. These risks, dangers and hazards may be caused by, without limitation, my participation in the Club’s Activities, the negligence of others, accidents, forces of nature, and/or other causes. These risks, dangers and hazards may be caused by foreseeable or unforeseeable causes, including but not limited to sports-equipment malfunctioning, sports-equipment misuse by me or others, and such other risks, dangers and hazards that are integral to the Club’s Activities.

I fully assume all risks, dangers and hazards and all responsibility for any and all injury (including, without limitation, death) and/or damages to me or my property or to any other person or their property that may arise in connection with my participation in the Club’s Activities.

I, on behalf of myself and my administrators, executors, legal representatives, and assigns, agree to and hereby do unconditionally release and discharge, the Club and its current, past or future parent, subsidiaries, related or affiliated companies or organizations, shareholders, directors, officers, employees, coaches, contractors, agents, representatives, insurers, consultants, predecessors, successors, transferees and assigns (collectively, the “Released Parties”), jointly and individually, from any and all past, present or future complaints, causes of action, suits, demands, claims, liabilities, promises, agreements, obligations, damages, assessments, losses, costs and expenses (including without limitation attorneys’ fees and court costs), known or unknown, foreseen or unforeseen, related to or arising from my participation in the Club’s Activities.

I hereby agree to indemnify, hold harmless and, upon request, defend the Club and its current, past or future parent, subsidiaries, related or affiliated companies or organizations, shareholders, directors, officers, employees, coaches, contractors, agents, representatives, insurers, consultants, predecessors, successors, transferees and assigns (collectively, the “Indemnified Parties”) from and against any and all claims, suits, actions,

proceedings, losses, costs, damages and expenses of whatsoever kind or nature, including but not limited to attorneys' fees and court costs, arising from or related to any bodily injury (including sickness or death) of any person or any loss, damage or destruction of tangible personal property alleged to have been caused, directly or indirectly, in whole or in part, by my acts or omissions.

I have read the above and, by signing, I agree to the statements made herein. It is my intention to exempt and relieve the released parties from all liability for personal injury, property damage or wrongful death arising from or related to the club's activities or my conduct. I hereby expressly assume and accept all risks associated with the club's activities.
